

WPSU-TV/Fullington Tours- National Parks Tour Contest

Eligibility

Contest entrants must be residents of Pennsylvania or New York, and at least 18 years old as of January 28, 2010. This contest is sponsored by WPSU, 239 Outreach Building, University Park, PA 16802. Employees, board members and advisory committee members of WPSU, its affiliates, advertising and production agencies related to this contest, and their respective household members are not eligible. All Federal, State and local laws and regulations apply. Void wherever prohibited or restricted by law.

How to Enter:

No purchase or contribution is necessary. Of course, we appreciate contributions, but sending a contribution will not affect your chances of winning.

Contest begins at 8PM Eastern Standard Time (EST) January 28, 2010 and ends at 11:00 PM EST on March 21, 2010 ("entry period.") Specifically, entries must be received in relationship to the weekly broadcast of "The National Parks" (January 28, February 3, 10, 17, 24, and March 3) or during the WPSU-TV Spring Fundraising Campaign starting March 6 and ending March 21.

You may enter this contest online or by phone. No other methods of entry will be accepted. To enter, call 1-800-245-9779 and speak to an operator or go to wpsu.org, follow the links to the pledge page, and click to submit during the entry period.

Entrants must EITHER a) complete all data requested through phone and online pledge or b) [submit a completely filled-out WPSU on-line pledge or phone form](#), including the following information, but not limited to: name, address, phone number with area code and e-mail address. All online and phone contributions executed through WPSU within the entry period are automatically entered provided the entrant has included his or her complete address, phone and email information. Incomplete entries are void. WPSU will not and does not share, sell or trade names, addresses, or any personal data of entrants and or members.

Selection of Winner

Winner will be selected in a random drawing from among all

eligible entries received by the deadline date above. Prize drawing will be conducted by WPSU. Drawing will be conducted on or about March 31, 2010.
